



Illinois Statewide Report of Methicillin-resistant *Staphylococcus aureus* (MRSA) Bloodstream Infections in Acute Care and Critical Access Hospitals, NHSN LabID Event Reporting, January 1, 2017 – December 31, 2017

As of January 1, 2012, all Illinois hospitals began mandated reporting of blood cultures positive for MRSA using the Center for Disease Control and Prevention's National Healthcare Safety Network (NHSN), Multidrug-Resistant Organism (MDRO) Laboratory-identified (LabID) Event module (http://www.cdc.gov/nhsn/PDFs/pscManual/12pscMDRO_CDADcurrent.pdf).

NHSN LabID reporting enables a facility to rely almost exclusively on data obtained from the laboratory and allows the calculation of proxy measures of MRSA events, exposures and healthcare acquisition. Positive lab results (LabID Events) are categorized as healthcare facility-onset (HO) or community onset (CO) based on when an individual is admitted to a hospital as a patient and when the lab specimen was obtained. LabID Events are categorized as HO if the specimen was collected on or after the fourth day of an inpatient hospital stay. Events are categorized as CO if the specimen was collected during the first 3 days of an inpatient stay. This report shows HO MRSA bloodstream data submitted to NHSN by acute care and critical access hospitals across Illinois from January 1, 2017 to December 31, 2017.

Standardized Infection Ratio and 95% Confidence Interval

The standardized infection ratio (SIR) is a measure that compares the HO MRSA bloodstream infection burden at a facility to that of the national referent population (2015 NHSN inpatient, facility-wide aggregate data). NHSN uses risk models that determine the predicted number of MRSA infections based on the national baseline data, adjusting for statistically significant risk factors (e.g., facility bed size and CO MRSA bacteremia prevalence rate). The model and factors used for risk adjustment depend on the facility type (e.g., acute care hospital or critical access hospital). A facility's SIR is calculated as the actual, or observed, number of HO incident cases reported by the facility divided by the predicted number of infections.

The corresponding 95% confidence interval (CI) is statistical measure that shows a range of estimated possible values for the SIR. The upper and lower bounds of the interval are used to determine the statistical significance and precision of the SIR. The SIR and 95% CI are interpreted as follows:

- If the 95% CI includes 1 (i.e., the lower bound is <1 and the upper bound is >1), the hospital's number of infections is similar to (not significantly different from) the predicted number.
- If the SIR is >1 and the 95% CI does not include 1, the hospital had a significantly higher number of infections than predicted.
- If the SIR is <1 and the 95% CI does not include 1, the hospital had a significantly lower number of infections than predicted.
